Archives regarding past Unity breakfasts were gathered and displayed at the 2022 Unity breakfast Service Fair which took place before the Unity Breakfast. Contact has been made with an old timer who, has been very active in service in Nassau County, for the purpose of recording an oral history and she has graciously agreed to participate in an oral history of her sobriety. The process of organizing the physical archives possessed by the Nassau General Service Group is underway. Our archives have been found to contain many unnecessary duplicates of materials collective as well as archives that are not connected to Nassau County but rather connected with SENY and the general service office. These items will be removed and submitted to SENY and the general service office and duplicates will be discarded as our archival space is limited. The 2022 National Alcoholics Anonymous Archives Workshop will be in Little Rock Arkansas this fall. The GSR reps voted to send me to the NAAAW in 2021 on a \$1,200 budget. That workshop was cancelled due to COVID and I am making a proposal to attend the 2022 NAAAW. As airfare has increased dramatically, I am proposing a new budget of approximately \$1,450. If the reps want to consider sending me to this year's National Alcoholics Anonymous archives Workshop. I am willing and available.

Nassau General Service Group Treasurer's Report for June 2022 Meeting

Revenues:

Group contributions through May are about 96% of what is expected based on the budgeted amount (\$5605 received/\$5833 budgeted prorated to 5 months). However, 7th Tradition contributions are greater than that budgeted.

Expenses:

Expenses for April and May include the following:

Line 17- \$315 for Conference Approved Literature used for displays at various events such as Share-A-Day, MADD, Unity Breakfast.

Line 24, Committee Chair Expenses- In April, \$79 for copies of the NICE bus posters and \$100 to MADD to allow for Nassau General Service display at Jones Beach event. In May, \$585, for Grapevine literature to be displayed at Unity Breakfast and other events.

There were no General Service event expenses for April or May.

Operating Income:

The operating income (Line 49) was positive for both April and May.
